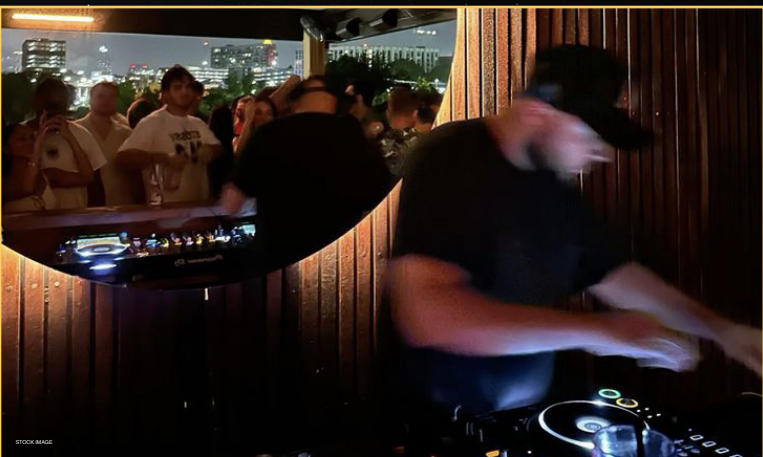
THE SKY CINEMA

A gallery of sound and sculpture, blending a mini amphitheatre for live performances with a relaxed heated pool that hums with quiet rhythm.

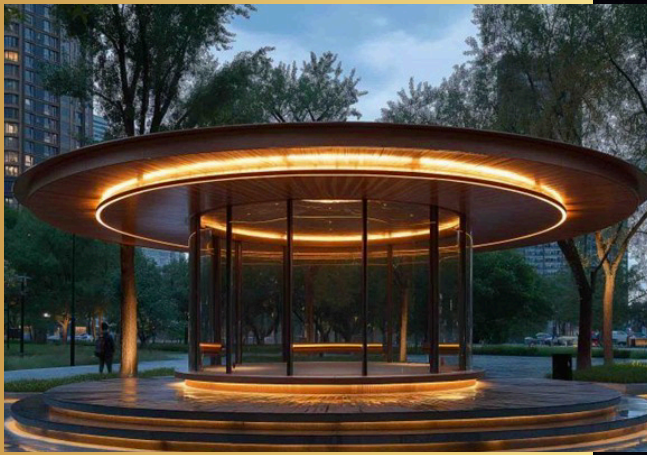


THE CONSERVATORY GARDEN

the city's most elevated address for leisure, art, and connection

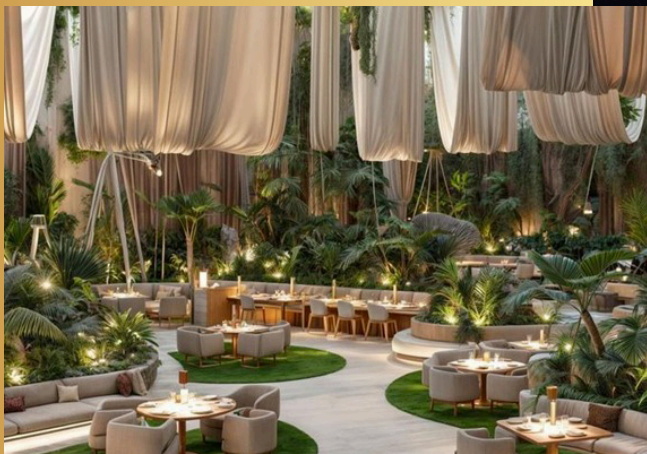

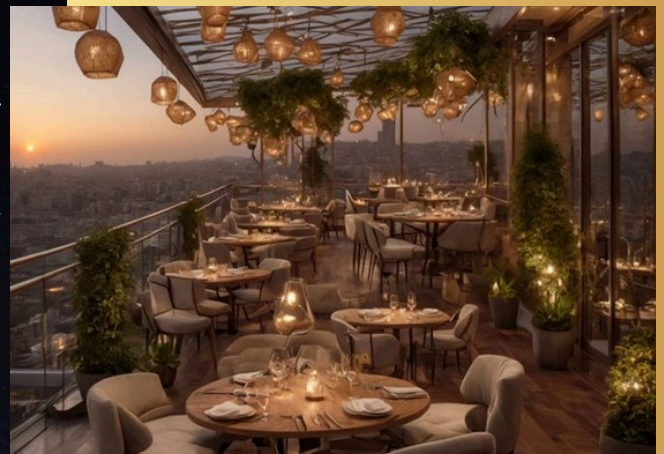
